EDITORIAL

We broke new ground when we held our first round table exchange of best EHS practices. Ms Stella Eccles, Managing Director of Pfizer Asia Pacific, led the discussion.

We continue to gain recognition. As reported previously, SLP was honored to be chosen by Schering-Plough Singapore to receive a grant of US \$ 2500 to promote excellence in EHS practice and performance.

A very successful training course for HAZOPS Leaders was held in November. See the article by Penny Pan. The course was conducted by John Lockwood who is an Honorary Fellow of SLP and a leading consultant in the EHS field. The course was targeted at participants who were being developed to be HAZOPS leaders by their companies. While participants came from a wide spectrum of industries, from batch to continuous plants and educational institutions, and there were differences in the HAZOPS experience of the participants, the feedback was positive. The case studies were appropriate. Participants also made use of the opportunities to net-work.
